Complainant alleges he is being harassed by officers who allegedly have stolen money from him and written false reports.

Rationale for administrative closure – Based on the Complainant’s failure to cooperate with the investigation. Complainant did not leave an address on his complaint form. Complainant indicated he was homeless. Several telephone calls were made to the telephone number listed on the complaint form and messages were left but never returned.
